James Fetzer: How we Know Sandy Hook was a FEMA Drill for Gun Control where Nobody Died

Dear Mr. President,

The nation over which you currently preside has been subjected to an on-going series of staged shootings, most of which—for maximal emotional effect—have involved the reported deaths of children, none more dramatically than the Sandy Hook Elementary School shooting in Newtown CT, on 14 December 2012, where Adam Lanza was alleged to have killed 20 first-grade children and six adults. But there were boundless anomalies here from the beginning, where even (what would have been thought to be) an innocuous photo of the parking lot gives the scam away.



Notice, in particular, the absence of familiar blue-and-white signage for handicapped parking, mandated by the Americans with Disabilities Act. Because this parking lot does not have such special parking, the school was not in compliance with the ADA and therefore cannot have been legal open in Connecticut in 2012. We have photos of entrances and exits no wheelchair could navigate, including a wooden staircase with a steel rod extending, which could pop out the eye of a little kid running toward the building. Sandy Hook Elementary was not an operating school.

Moreover, because it was a 28°F ground temperature day, the school could not have housed students without heating the building; but there is no heat or steam rising from the structure, no doubt because it

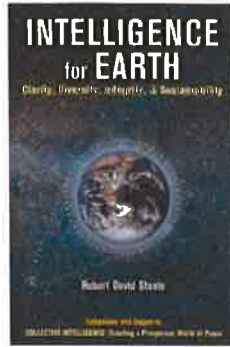

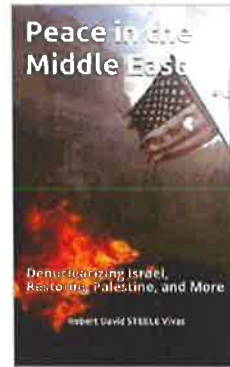
appears to have been closed by 2008, the furnaces were rusted out and dysfunction from lack of use. Notice the center rows of cars are all parked facing the school, which violates the driving instructions to turn right, curl around and park facing away. It was just too convenient to bring them in as props in a single line and put them in place, two-by-two.

When I published **NOBODY DIED AT SANDY HOOK** (2015), with fifteen contributors (including six current or retired Ph.D. college professors), we proved the school had been closed by 2008 and there were no students there. **One contributor, Paul Preston, who had run drills for school systems as an administrator in the past, was so bothered by what he observed being reported that he reached out to his contacts in the Obama Department of Education, all of whom told him that it had been a drill, that no children had died and that it was done to promote gun control. [PBI Emphasis Added.]**

The book includes two chapters with 50 photos each, Ch. 7 of furnishing an empty house to serve as “the Lanza residence”, Ch. 8 of refurbishing the school to serve as the stage for the 2-day FEMA exercise, where we even include the FEMA manual as Appendix A. One photo in Ch. 8, Exhibit 26, shows (what we initially took to be) a SWAT vehicle present before the shooting had taken place—which is provable because the windows of Classroom 10, which would be shot out after the event, are intact. The flag is at full mast and, when you track down the staff, Wayne Carver, Medical Examiner, is patiently awaiting arrival of his portable mortuary tent.

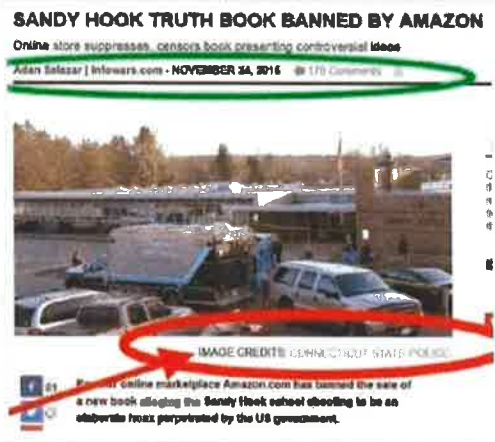

When the book was banned less than a month after having sold nearly 500 copies, I released it to the public for free as a pdf, where anyone can download it to their own desktop by entering the title in their browser. When *Infowars.com* reported the ban, they featured Exhibit 26 even more clearly than in the printed book. But it was taken down about 38 minutes later after 178 comments, no doubt because of image credit to CONNECTICUT STATE POLICE, which William Powell had discovered had documented their own participation in the scam in their own files.



Among oddities of the press conference held by Wayne Carver, which James Tracy documented in his brilliant expose thereof, was that they did not allow the parents to see the bodies of their children but instead identified them using photographs. That was a violation of CT protocols but appropriate under the circumstances, since it turns out that the children were fictions who only existed in the form of photographs. "Noah Pozner", shown here, for example, was made up out of photos of his "older step-brother", Michael Vabner, which we have confirmed multiple ways.

Kelley Watt had over 100 hours of conversation with "Lenny Pozner", who purports to be his father and who sent Kelley a death certificate for "Noah" as proof that he had died, which we included in the book. It turned out to be a fabrication, with the bottom half of a real death certificate and the top half of a fake, with no file number and the wrong estimated time of death at 11 AM, when "officially" the shooting took place between 9:35-9:40 that morning. Mona Alexis Pressley has now shown that "Lenny" is actually Reuben Vabner, Michael's father.

Indeed, it appears that some of the "parents" may have used photos of themselves as children to perpetrate this highly-successful fraud upon the public. Without the complicity of the media and local, state and federal authorities, a scam of these dimensions could not have successfully been foisted upon the public—which continues as "Lenny Ponzer" and other fake parents are deceiving the Court by offering false testimony and concealing their identities in their suits against Alex Jones. Sandy Hook was faux terrorism to manipulate the public and promote the Obama administration's political agenda.

I am an attorney for Leonard Pozner. You have each published false statements accusing Mr. Pozner of circulating a forged copy of his son's death certificate.

Each of these statements is false because Noah Pozner's death certificate is not a forgery. You can confirm that the death certificate that Mr. Pozner circulated is an official state record by obtaining a copy through Connecticut's State Vital Records office.

We demand an immediate, unequivocal retraction of your false statements.



Lenny Pozner, father of Noah, a victim of the December 14, 2012 Sandy Hook Elementary School mass shooting, is suing Professor James Fetzer. *[Editor's note: See "The Sandy Hook "Pozner v. Fetzer" Lawsuit for Dummies" for the basic elements of the case.]*

Central to the lawsuit is Noah Pozner's death certificate. The lawsuit claims that Fetzer has "defamed" Lenny by asserting in books and his blog that Noah's death certificate, which Fetzer had received from an individual named Kelley Watt who claims her source to be Lenny himself, is fraudulent. In the lawsuit, Lenny provides an image of what he claims to be Noah's real "official" death certificate – Attachment A on page 15 in *Pozner v. Fetzer Civil Complaint & Demand For Jury Trial*, filed on November 27, 2018, at the Circuit Court of Dane County, Wisconsin.

We will number the Fetzer-Watt document as Death Certificate #1, which is Exhibit A on page 4 of Fetzer's *Request For Admissions*, filed on January 24, 2019, at the Circuit Court of Dane County, Wisconsin. We will number the image

that Lenny provided as Noah's "official" death certificate as Death Certificate #2.

Death Certificate #1:

Below is a screen shot of Death Certificate #1 – Noah's death certificate that Fetzer had received from Watt, who in turn had received it from Lenny Pozner himself. Note the following:

- The top right box (circled pink) for the death certificate's State File Number is blank.
- The words in three boxes are blacked out: two side-by-side boxes for the name and location of the cemetery, and a box in the lower right labeled "Social Security Number" of the decedent, Noah.
- There is no seal of the State of Connecticut at the bottom of the certificate.

Kelley Watt has provided Fetzer with an affidavit stating that the source of Death Certificate #1, Exhibit A in Fetzer's *Request For Admissions*, is Lenny Pozner himself. That then leads to this question: How did Lenny get hold of Noah's death certificate BEFORE it received a file number and BEFORE the State of Connecticut certified the certificate with its seal?

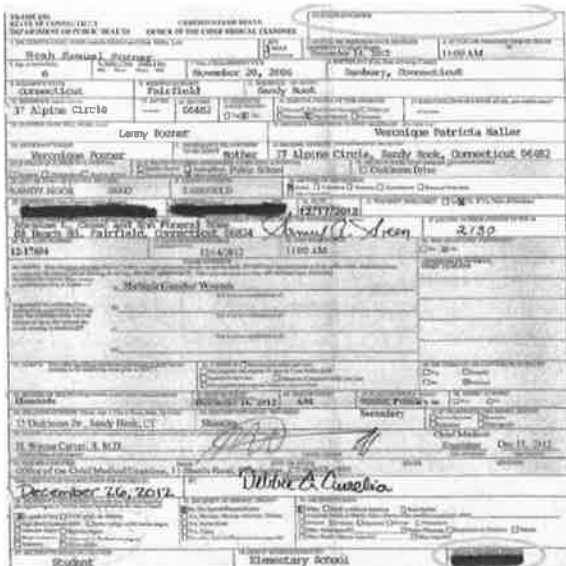

Curiously, there are at least two other online versions of Noah's death certificates, identified as Exhibits C and D on pages 6 and 7 in Fetzer's *Request For Admissions*. We will call them Death Certificate #3 and Death Certificate #4.

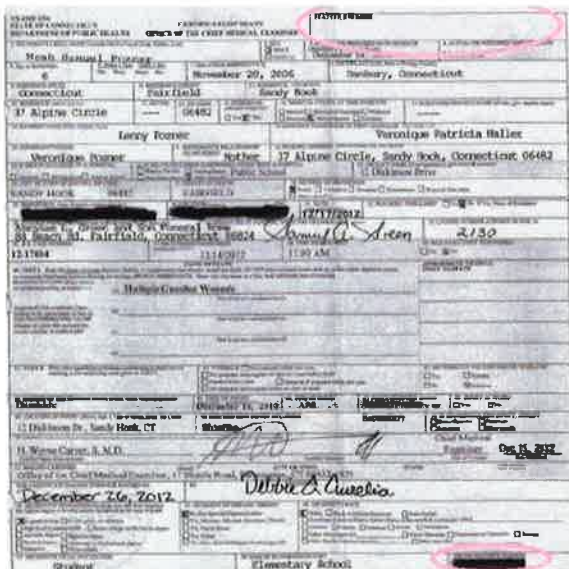
Death Certificates #3 and #4:

A June 10, 2017 post on the blog, *SandyHookFacts.com*, has two images of Noah's death certificate:

(1) A "parent copy" that was released by Lenny Pozner in 2014, which is identical to the Death Certificate #1 that Kelley Watt gave Fetzer. We will call this "parent copy" Death Certificate #3.

Below is a screenshot of Death Certificate #3. Note the following:

- Like Death Certificate #1, the box for State File Number is blank.
- Like Death Certificate #1, the box for Social Security Number is blacked out.
- Like Death Certificate #1, there is no certified seal of the State of Connecticut at the bottom of the certificate.



(2) The same source, *SandyHookFacts.com*, also published another version of Noah's death certificate, which the blog calls a "public" copy that is a "Certified Death Certificate" obtained in 2016 from Newtown Town Clerk, which "was

released on video by SandyHookFact.com" – "the premire release of this document by blog." We will call this "public copy" Death Certificate #4.

Below is a screenshot of Death Certificate #4. Note the following:

- In the box for State File Number is a partial printed number 0243. Recall that the handwritten State File Number in Death Certificate #2 is 2012-07-078033.
- Boxes 54-58 and the box for Social Security Number that are in Death Certificates #1, #2 and #3 are missing.
- Nor does Death Certificate #4 have the seal of the State of Connecticut at the bottom, which is also missing in Death Certificates #1 and #3.



Death Certificate #5:


Then there is Death Certificate #5, Noah Pozner's definitive, official death certificate, certified by the State of Connecticut, with an issue date of March 20, 2019. Anyone can obtain a certified copy of any Connecticut death certificate by going to:

We will call this Death Certificate #5. Note the following:

- Like Death Certificate #2, and unlike Death Certificates #1, #3 and #4, the top right box has a handwritten State File Number 2012-07-078033.
- The bottom right box for Noah's Social Security Number is blank, but the blankness appears to be a result of erasure (or "whiteout"). The printed words "Social Security" of "Social Security Number" and a little bit of the bottom line are also erased.

To conclude, there are at least four different versions of Noah Pozner's death certificate:

(1) Certificates #1 (Fetzter's copy of the death certificate obtained from Kelley Watt) and #3 (death certificate posted on SandyHookFacts.com) appear to be identical and share these characteristics:

- A blank State File Number box.
- Three boxes are blacked out: two side-by-side boxes for the name and location of the cemetery, and a box in the lower right labeled "Social Security Number" of the decedent, Noah.
- No seal of the State of Connecticut at the bottom of the certificate.

(2) Certificate #2, Attachment A in Pozner v. Fetzter Civil Complaint & Demand For Jury Trial, which Lenny Pozner claims to be Noah's "official" death certificate, has the following characteristics:

- Unlike Death Certificates #1 and #3, there is a handwritten State File Number 2012-07-078033 in the top right box.
- The lower right box for the decedent's (Noah's) Social Security Number, which was blacked out in Death Certificates #1 and #3, is blank.
- Unlike Death Certificates #1 and #3, there is the seal of the State of Connecticut at the bottom of this certificate.

(3) Certificate #4, which SandyHookFacts.com claims to be a "public" copy of a "Certified Death Certificate" obtained in 2016 from Newtown Town Clerk, has the following characteristics:

- There is a partial printed, not handwritten, number 0243 in the box for State File Number, which is completely different from the handwritten State File Number 2012-07-078033 in Death Certificate #2.
- Boxes 54-58 and the box for Social Security Number that are in Death Certificates #1, #2 and #3 are missing.
- Like Death Certificates #1 and #3, there is no seal of the State of Connecticut at the bottom, although SandyHookFacts.com says Death Certificate #4 is a "Certified Death Certificate".

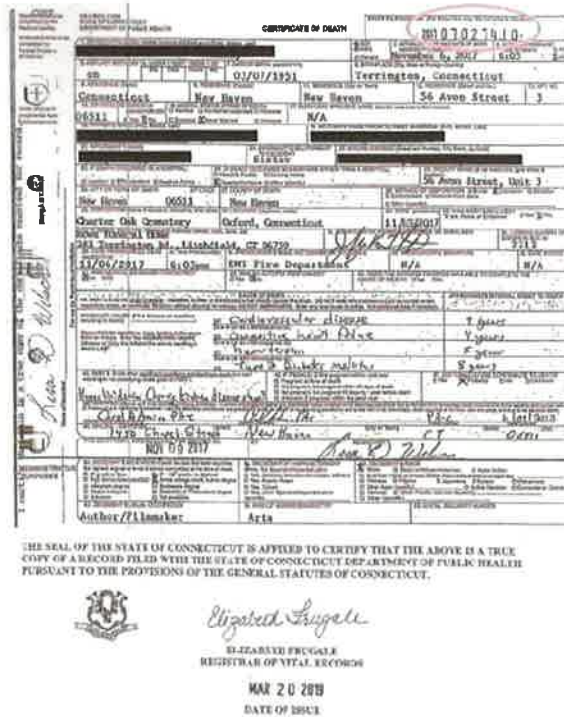
(4) Death Certificate #5, the official certified copy of the death certificate issued by the State of Connecticut on March 20, 2019, with the following characteristics:

- Like Death Certificate #2, but unlike Death Certificates #1, #3 and #4, the top right box has a handwritten State File Number 2012-07-078033.
- Unlike Death Certificate #2, instead of being blacked out, the box for Noah's Social Security Number is blank, but the blankness appears to be a result of erasure (or "whiteout").

One last curiosity:

Note that both Death Certificates #2 and #5 have a handwritten State File Number 2012-07-078033, but the words in the other boxes (except for signatures) are all typed.

Below is a screen shot of the certified death certificate of X, a man who died in New Haven, Connecticut on November 6, 2017, which was issued on March 20, 2019. X's name and the names of his relatives (Boxes 18-22) are blacked out in the interest of privacy. Note that the State File Number of X's certified death certificate 2017 07027410 is printed, not handwritten as in Noah's certified death certificate (#5).



To conclude:

Assuming that Death Certificate #5, the certified copy of Noah Pozner's death certificate that was issued by the State of Connecticut's Registrar of Vital Records on March 20, 2019, is the "real" death certificate, since it differs from Death Certificates (DC) #1, #2, #3, and #4, that would make those four death certificates fraudulent – including the Fetzter-Watt copy (DC #1), the subject of Lenny Pozner's lawsuit against James Fetzter, as well as the death certificate Lenny claims to be Noah's "official" death certificate (DC #2) which he included in *Civil Complaint & Demand For Jury Trial* as Attachment A.

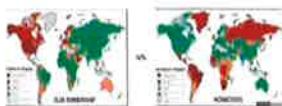

"Varied certificate formats" could never make Dr. Fetzer's observations a non-issue. (The contents for the fields or boxes on the form is the right and obvious focus of Dr. Fetzer et al.)

I see a few variances in the fields in the way they are laid out or placed on the form with #1 through #4 but I regard #5 as the ONE death certificate that was officially submitted by the county to the state and received by and certified by the State of Connecticut's Registrar of Vital Records on March 20, 2019 (Elizabeth Frugale). The state Registrar does not provide official certification and affix the seal to more than one certificate on the same person.

It is highly unlikely that a county would officially submit more than one certificate on the same person to the state. (It would not even be what could be called a "mistake" if ever two certificates on the same person with each certificate being on a different form - that would be blatant fraud.)

It is even more unlikely that the state registrar would not have tight internal controls that would prevent official certification and seal to be placed on more than one certificate on the same person, should in the rare case two death certificates on the same person would be received by the state.

OF INTERROGATORIES**

Alexander J. Petale, Esq., counsel for Defendant Wrongs Without Wremedies, LLC, answers to Plaintiff's First Set of Interrogatories as follows:

Interrogatory No. 1: If you contend that Plaintiff is a limited purpose public figure, describe with particularity the public controversy into which you contend Plaintiff has injected himself, including specific citation to any documents or other evidence that supports the existence of such public controversy and Plaintiff's role in that public controversy.

Defendant's Answer: The landmark Supreme Court case *New York Times Company v. Sullivan* 376 U.S. 254 (1964) set the bar extremely high for those public figures wishing to prove they have been defamed, as they must prove "actual malice" to recover for claims based on speech, and that a defendant was operating with knowledge that what they were saying was false or with reckless disregard of whether it was false or not. In fact, the primary holding of *New York Times Company v. Sullivan* is that "to sustain a claim of defamation or libel, the First Amendment requires that the plaintiff show that the defendant knew that a statement was false or was reckless in deciding to publish the information without investigating whether it was accurate." *Gertz v. Robert Welch, Inc.*, 418 U.S. 323 (1974) added to a plaintiff's burden in proving defamation, ruling that plaintiffs must prove that a defendant "acted negligently or with an even higher level of *mens rea*," meaning that a defendant *knew* they would be committing a crime.

Defendant believes Plaintiff is a public figure, as he admits to in his Complaint, where he states that "Prior to undertaking such responses, Plaintiff had no meaningful public presence." Plaintiff goes on to admit that he has undertaken efforts to raise his public profile: "Plaintiff has undertaken efforts to respond to and debunk false statements and denigration of the memory of his murdered son."

Out of all the parents who claim to have lost children at the Sandy Hook Elementary School shooting, Plaintiff is arguable the most recognizable, as he has pushed his way onto the public stage, securing opinion pieces in some of the nation's largest newspapers and air time in

front of the nation's largest broadcasters.

Additionally, Plaintiff initiated and instigated a battle to get Dr. James Tracy fired from his tenured teaching position at Florida Atlantic University simply for publicly sharing his doubts and concerns with the official narrative of the Sandy Hook Elementary School shooting, a successful venture which was extensively covered by the world's print, broadcast and digital media.

In many ways, Plaintiff is the face of the Sandy Hook Elementary School shooting.

While courts have ruled that there are two types of public figures recognized under defamation law—"all-purpose" and "limited-purpose"—Plaintiff clearly falls into the latter category, which is defined as individuals who "have thrust themselves to the forefront of particular controversies in order to influence the resolution of the issues involved." Plaintiff is a textbook example of a "limited-purpose" public figure, as these are "individuals who deliberately shape debate on particular public issues, especially those who use the media to influence that debate." As the courts have ruled that a "limited-purpose" public figure is "one who voluntarily becomes a key figure in a particular controversy," Defendant believes Plaintiff's actions since the Sandy Hook Elementary School shooting have established his "limited-purpose" public figure status. Additionally, as the courts have ruled that public figures "who seek damages for defamatory statements must show that the statements were made with actual malice—that is, with knowledge that the statements were false or with reckless disregard as to their falsity"—Plaintiff "must establish actual malice by clear and convincing evidence." Defendant acted with no malice toward Plaintiff.

Interrogatory No. 2: If you contend that the death certificate reproduced in the Book is different than the death certificate appended hereto as Ex. A, identify with particularity each such difference.

Defendant's Answer: The death certificate provided by Lenny Pozner to Kelley Watt has significant differences from the death certificate attached to Plaintiff's Complaint.

Interrogatory No. 3: If you contend that you were prejudiced by Plaintiff's alleged delay in bringing this claim, describe with particularity prejudice you allegedly suffered because such delay.

Defendant's Answer: The first edition of *Nobody Died at Sandy Hook* (2015) went on sale on 22 October 2015 on amazon.com and was banned by amazon.com on 19 November 2015 after selling nearly 500 copies. Plaintiff made no complaints for over three years from the filing of this lawsuit. Defendant was led to believe Plaintiff had no objections to the contents of both editions of the book.

Interrogatory No. 4: If you contend the allegedly defamatory statements did not injure Plaintiff's reputation, describe with particularity all evidence in support of such contention.

Defendant's Answer: Objection, discovery and investigation is continuing. It is Plaintiff's burden to produce evidence of his damages. Based upon the incomplete state of discovery at this time, Defendant is unable to answer this question.



**DEFENDANT FETZER'S ANSWERS TO PLAINTIFF'S FIRST SET OF
INTERROGATORIES**

Defendant Fetzer (hereinafter "Defendant"), representing myself pro se, respond to Plaintiff's First Set of Interrogatories as follows:

Interrogatory No. 1: If you contend that Plaintiff is a limited purpose public figure, describe with particularity the public controversy into which you contend Plaintiff has injected himself, including specific citation to any documents or other evidence that supports the existence of such public controversy and Plaintiff's role in that public controversy.

Defendant's Answer: Defendant has no doubt Plaintiff is a public figure, as Plaintiff admits in his Complaint, where he states that "Prior to undertaking such responses, Plaintiff had no meaningful public presence." Plaintiff goes on to admit that he has undertaken efforts to raise his public profile: "Plaintiff has undertaken efforts to respond to and debunk false statements and denigration of the memory of his murdered son."

Out of all the parents who claim to have lost children at the alleged Sandy Hook Elementary School shooting (hereinafter “SHES”), Plaintiff is arguably the most recognizable, as he has pushed his way onto the public stage, securing opinion pieces in some of the nation’s largest newspapers and air time in front of the nation’s largest broadcasters and has filed widely-publicized lawsuits against SHES skeptics such as Wolfgang Halbig—a suit from which Plaintiff withdrew when ordered by the Court to sit for a video deposition—and Alex Jones, who has been on both sides of the issue, which continues even as this case against Defendant has been filed and proceeds forward. Additionally, Plaintiff initiated and instigated a battle to get Dr. James Tracy fired from his tenured position as an Associate Professor of Media and Communications at Florida Atlantic University simply for inquiring as to whether Plaintiff had a legitimate copyright for images of his alleged son, “Noah Pozner”, and for undertaking efforts to ensure that the public was not being ripped off by an elaborate scam through theft by deception out of concerns, which are widely shared by other academicians who have studied the evidence in this case—including the six (6) current or retired Ph.D. professors who contributed chapters to *Nobody Died at Sandy Hook* (2015; 2nd ed. 2016), which established that the school had been closed by 2008, that there were no students there, and that it was a FEMA exercise presented as mass murder to promote gun control—where Plaintiff’s false allegations against Professor Tracy were widely reported in major national publications, such as *The New York Times*, *The Washington Post* and (even) *The Chronicle of Higher Education*, not to mention the south Florida *Sun-Sentinel*, *The Palm Beach Post*, the Jewish journal *Forward*, and a host of international publications including the UK’s *Guardian*, publicly sharing his doubts and concerns with the official narrative about SHES, which would be the conclusion reached by any reasonable person who knew, for example, that the FBI’s Consolidated Crime Report for 2012 shows zero (0) murders in Newtown, and that Danbury State’s Attorney Stephen J. Sedensky III’s

report on SHES fails to establish a causal nexus connecting the alleged shooter, Adam Lanza, to his purported victims or the weapons he is said to have used.

Plaintiff could aptly be characterized as “the face” of SHES. Compare the name of any other party even remotely associated with SHES and it is no contest: not even then-Connecticut Chief State Medical Examiner H. Wayne Carver II, who explained to the public that the parents were not allowed to view the bodies of their children, but identify them on the basis of photographs instead, or Gene Rosen, who claimed to have had four, five or six children (depending on the telling) dropped off at his home by a bus driver (as though a school bus driver would leave children at the residence of someone who was not their parent or guardian), are virtual “unknowns” compared with Plaintiff, as any Internet search immediately reveals. The number of news stories published in newspapers, magazines and on television in which Plaintiff was the central figure has to be enormous, where efforts to minimize Plaintiff’s place in public discourse about SHES for the sake of preserving a false impression about his standing are laughable, and represent another effort to perpetrate a fraud upon the Court by means of allegations inconsistent with truth. Not to mention Plaintiff’s own acknowledgement to having taken down over 10,000 “content items” from the Internet using the HONR Network, a cyber-terrorist organization, which is completely obscene.

have ruled that a “limited-purpose” public figure is “one who voluntarily becomes a key figure in a particular controversy,” Defendant believes Plaintiff’s actions since SHES have decisively established his “limited-purpose” public figure status. Additionally, as the courts have ruled that public figures “who seek damages for defamatory statements must show that the statements were made with actual malice—that is, with knowledge that the statements were false or with reckless disregard as to their falsity”—Plaintiff “must establish actual malice by clear and convincing evidence.” Since Defendant is known for presenting one fact after another and one proof after another during interviews across various media when discussing Defendant’s reasons for concluding that SHES was a FEMA drill where nobody died—as, indeed, is conveyed by the title of the book, *Nobody Died at Sandy Hook* (2015; 2nd ed., 2016), which Defendant edited—Plaintiff has to know full-well that Defendant believes what he says about SHES and has an abundance of proof to confirm it, which even includes the FEMA manual for a mass casualty exercise involving childing beginning at 8 AM 13 December 2012 and ending at 11:59 PM to be evaluated the following day, published as Appendix A in the book, with copious photographs that show events on the ground corresponding to FEMA requirements from the sign, “EVERYONE MUST CHECK IN”—which Patricia Llorda, the First Selectman of Newtown (equivalent to mayor) acknowledged (under oath during a formal hearing on the State of Connecticut’s failure to comply with Wolfgang Halbig’s FOIA requests)—had been placed there by the U.S. Department of Homeland Security; the presence of restrooms and provision of refreshments, large numbers of persons wearing name tags on lanyards, and even parents bringing children to the scene. No parent would have brought their child to the scene of a child-shooting massacre, but this was only an exercise and was being treated as a festive occasion as documented in Defendant’s 96-minute long video, “Sandy Hook

Update: Tracy loses, Wolfgang wins. The Deep State Strikes Back!” (14 January 2018), available to the public at BitChute.

Interrogatory No. 2: If you contend that the death certificate reproduced in the Book is different than the death certificate appended hereto as Ex. A, identify with particularity each such difference between the two documents.

Defendant’s Answer: Differences between the document Plaintiff has attached as Exhibit A and the document Plaintiff gave to Kelley Watt, which Defendant has addressed in his books, lectures and other fora, which is attached as Exhibit B, including the following, apparent from inspection:

1. Exhibit A bears a file number (handwritten 2012-07-078033) and a state certification across the left side. Exhibit B bears neither indication of authenticity.
2. Exhibit A bears a typewritten note across the top, saying “boxes 12 & 22 corrected as per Father 6-14-13 Leonard Pozner.” Exhibit B does not bear this note. (Also, the typewritten reference to “Father . . . *Leonard* Pozner” is inconsistent with the father’s name as printed on Exhibit 1, which is “*Lenny* Pozner.”) [Emphasis added.]
3. The content of the boxes that were changed is, in the case of box 12, the address for the decedent from the original “37 Alpine Circle” to “3 Kale Davis Road”.
4. In the case of box 22, the address for the parents is changed from the original “37 Alpine Circle” to “3 Kale Davis Road.”

5. Exhibit B is darker in the bottom two-thirds than it is in the top one-third, suggesting that this was a fabrication combining the bottom half of a different death certificate with the top half of a fake (which Defendant Fetzer believes was probably lightened and smoothed digitally in Exhibit A).

6. Both certificates give the estimated time of death at 11 AM, when the official narrative declares the shooting to have taken place between 9:30 AM and 9:40 AM.

7. The final box of Exhibit A—designated for the decedent’s Social Security Number (hereinafter “SSN”)—is blank, while the same space of Exhibit B is redacted, as though there had been an SSN there that needed to be redacted.

Interrogatory No. 3: If you contend that Noah Pozner is actually Michael Vabner, describe in detail all evidence for such contention.


Defendant’s Answer: Kelley Watt was the first to notice the resemblance. Several of us took on the project and found that they had the same eyes, eyebrows, nose, mouth, ears and shape of skull. The basics are presented many places, but the most convincing is the GIF— Graphics Interchange Format—where you can see “Noah Pozner” turn into Michael Vabner. A review of exhibits attached to Defendant’s Second Set of Requests for Admissions covers the bases fairly well. No doubt, by far the most important objective and scientific proof derives from superpositions when the distance between the pupils is set the same, which can be displayed most effectively in GIFs, which you can find in the video, “Sandy Hook Update: Tracy loses, Wolfgang wins. The Deep State Strikes Back!” (14 January 2018), another example of which may be found on my blog,

There are many other good reasons to conclude that “Noah” is a fiction made up out of photographs of his purported older step-brother, including the fabrication of passport for “Noah Samuel Pozner”, the fabrication of a death certificate and the mountain of proof that the Sandy Hook event was in fact a FEMA drill where nobody died as the book, *Nobody Died at Sandy Hook* (2015; 2nd ed., 2016), with thirteen contributors, including six (current or retired) Ph.D. professors, has already shown.





As stated in the undersigned's MOTION FOR LEAVE TO APPEAR AS FRIEND OF THE COURT, the undersigned became a student of the Sandy Hook School Shooting following the events of 14 December 2012 and published a collection of research studies in collaboration with a dozen other experts and scholars, including six other Ph.D. (current or retired) college professors. We established that the school, which was loaded with asbestos and other bio-hazards, had been closed by 2008 and that there were no students there. What has been presented to the public as a shooting massacre was in fact a FEMA drill, where we even have the manual,

which he included in the book, *Nobody Died at Sandy Hook* (2015), as Appendix A. 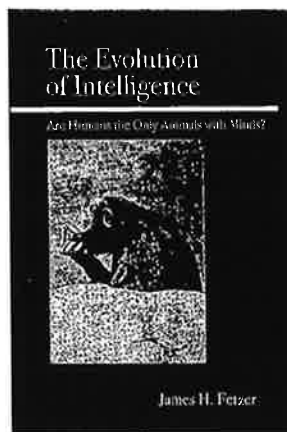

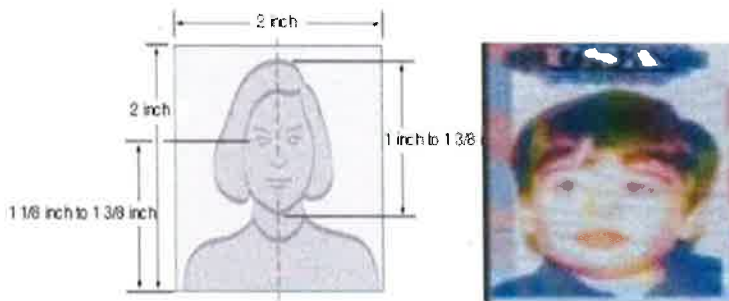

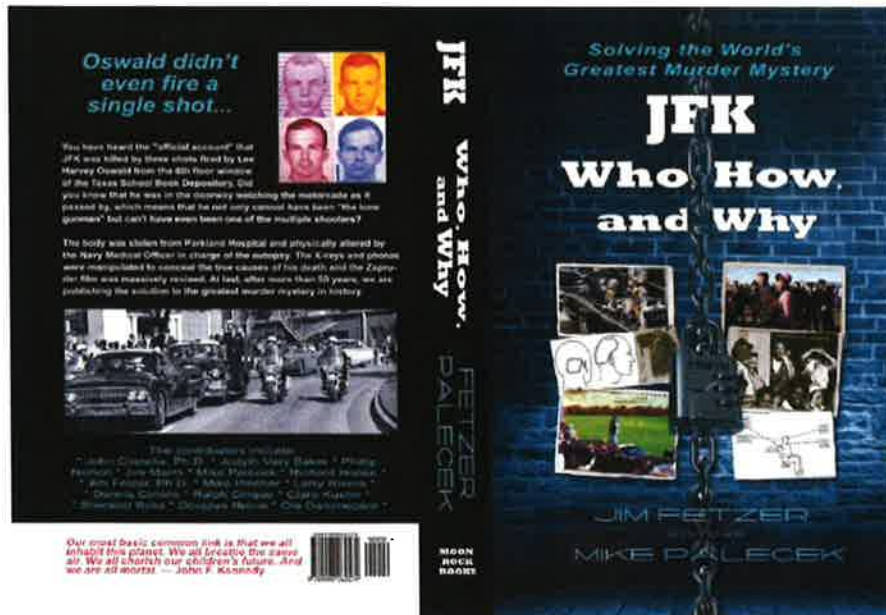
What's wrong with this picture? Let me count the ways. How many can you find?
